Acceptance of Risk and Release of Liability

Acceptance of the terms and conditions of this release and adherence to Dog Park rules are conditions of license approval, retention, and renewal for use of the Monroe Dog Park, hereinafter referred to as the Dog Park. The City of Monroe, hereinafter referred to as the City, may suspend or revoke my license for non-compliance.

I hereby acknowledge that I have voluntarily applied for a license to use the Dog Park operated by the City with my dogs. I understand that (1) unleashing my dog(s) and being physically present at the Dog Park involves risk of injury to myself, my dogs and others. Injuries may result from such things as aggressive dogs, unpredictable behavior, or lack of training; and (2) that despite the efforts of the City to ensure owners have complied, there is a risk that not all dogs present in the Dog Park are licensed and vaccinated, which could result in injury to a human or a dog; and (3) the City does not guarantee that dogs in the park are safe or healthy; and (4) additional risks include, but are not limited to, escape over and under fences, high-speed traffic on a highway immediately adjacent to the dog park, dog fights, dog bites, theft, disappearance or unlawful capture of dogs, being knocked-down, chased or tripped by a dog, vegetation or standing water that may be unhealthy if consumed, and (5) use of the dog park is self-directed and not directly supervised by an agent of the City, and (6) violation of the terms of this release, the dog park rules, or any applicable condition, regulation, or provision of state statutes, City ordinances or resolutions, may result in suspension or revocation of my Dog Park license and Dog Park privileges.

I further acknowledge that I (1) have carefully read this release of liability and understand it fully; and (2) agree with and accept its terms and conditions; and (3) have received a copy of the rules for Dog Park usage and agree to abide by these rules and to inform any authorized household members under my license and all other individuals who may accompany us into the Dog Park of these rules and will ensure their compliance with the rules; and (4) agree to immediately report any unsafe property conditions to the City and (5) am not aware of any instance in which the dog(s) I am requesting an annual Dog Park tag for has shown aggressive fighting or biting behavior towards other animals or people.

I assume all risks associated with using the Dog Park, including the risk of injury to my dogs, myself, any authorized household members under my license, and all other individuals who may accompany us into the Dog Park. In consideration of receiving a City license to use the Dog Park, I hereby fully and forever release and discharge the City and its elected officials, officers, employees, volunteers, and agents from any and all negligent acts or omissions in the same, claims, demands, damages, rights of action or causes of action present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of the use or intended use of said Dog Park and off-leash area premises by myself, authorized household members under my license, and any individuals accompanying us into the park.

I hereby assume sole responsibility for and agree to indemnify, hold harmless, and defend the City, its elected officials, officers, employees, volunteers, and agents from and against any and all claims (bodily injury, death, or other), litigation, judgments, settlements, costs, and expenses that include the reasonable cost of investigation, court costs and reasonable legal fees, expert fees, and other expenses that may arise from the use of the Dog Park by myself, authorized household members under my license, and by anyone else accompanying us into the Dog Park. If any circumstance shall arise related to the use of the Dog Park in which any authorized household members or persons accompanying me or my authorized household members into the park are entitled to indemnity or defense pursuant to this release, I agree that upon written notice thereof, I shall immediately assume the defense thereof, including the employment of counsel.

I have carefully read and understand this release of liability and fully agree to be bound by the contents thereof.

MONROE DOG PARK RULES

The following regulations apply at the Monroe Dog Park:

1. A valid dog park license is required for use of the park.
2. Owners are legally responsible for their dogs and any injuries or damages caused by their dogs.
3. All dogs must be spayed or neutered.
4. Dog feces (and/or dog waste) must be cleaned up and properly disposed of by owners immediately.
5. All dogs must be on a leash until inside the fenced area.
6. Dog owners must carry a leash at all times, closely supervise their dogs, and at no time may the owner leave the fenced area without his/her dog.
7. Gates must be closed except when entering or exiting the off-leash area.
8. Dogs must wear a current Monroe Dog Park tag and current rabies vaccination tags.
9. Dogs must be under voice control at all times. Owners must stop dogs from digging and must fill any holes caused by their dogs.
10. Pinch, spike, and choke collars must be removed prior to entering the fenced off-leash area.
11. No children under ten (10) years of age allowed; older children must be under adult supervision. Dog handlers/owners must be 16 years of age.
12. No one may conduct any kind of commercial or professional business in the dog park without approval from the city.
13. No climbing on or over the fence.
14. No smoking or tobacco use inside the fenced area.

The following are not allowed in the fenced area of the dog park:

1. Dogs in heat.
2. Aggressive dogs or dangerous dogs as defined in the Municipal Code.
3. Dogs that are ill or injured.
4. Puppies under six months of age.
5. Animals other than dogs.
6. Alcoholic beverages.
7. Food, dog treats, rawhide, or glass containers.
8. Bicycles, skateboards, roller skates or blades, or any motorized vehicles, except wheelchairs.

The word "owner" means a person who holds a valid dog park license and household members designated in such license to use the dog park.

A dog owner who fails to comply with the above rules may be asked to leave the dog park and may have their license revoked or suspended.
